MN-DONA COMMITTEE OPPORTUNITIES

Nominating Committee: The Nominating Committee shall serve the membership body by soliciting and securing candidates for offices and District Directors as needed and outlined in this Constitution, preparing and presenting the ballot to the members prior to the annual meeting.

<u>Constitution/Bylaws Committee:</u> The Constitution/Bylaws Committee shall draw up, word and prepare any and all amendments to the existing Constitution and Bylaws.

<u>Scholarship/Education Committee:</u> The Scholarship/Education Committee shall study the feasibility and appropriateness of all scholarships, participate in certification of the Director of Nursing as well as promote long term care curriculum development. The committee will administer and award all available scholarships. This committee will recommend to the Executive Committee expenditures for the education development of all members.

<u>Legislative Committee:</u> The Legislative Committee shall report to the membership at the annual meeting regarding legislative efforts promoted by this organization as outlined in the objectives (Article II) of the MN-DONA Constitution and ByLaws, and they shall endeavor to keep the membership body informed of matters of legislation pertaining to long term care.

<u>Publicity/Membership Committee:</u> The Publicity/Membership Committee shall endeavor to promote the organization by way of all public and industry media. Copies of all such endeavors shall be placed in the organization scrapbook. This committee shall promote membership of the organization.

<u>Finance Committee:</u> The Finance Committee shall be responsible for the preparation of a budget for the fiscal year and for submitting it to the organization at its general membership meeting for approval.

Spring Connection Committee: The purpose of this committee is to plan and coordinate the Spring Connection for the educational development of nursing management in long term care.


