MN-DONA's COVID-19 Policy for Fall Conference

Due to the Delta Variant and COVID-19 MN-DONA is implementing the following policy for the MN-DONA's Fall Conference 2022

- Masking: Masks are required while inside/in public areas and not actively eating or drinking.
- Must be vaccinated (Final shot plus 14 days) **OR** negative COVID-19 test within 72 hours of start of conference (Noon on Wednesday October 5.)
- Your normal at home daily screening for COVID-19 symptoms before you go to work.

Proof of vaccination or negative COVID-19 test will be done at the **Registration Desk on the first floor outside the Minnesota Ballroom.** Information will not be stored or physically collected.

Proof of COVID vaccination can be original, copy or photo of:

- COVID-19 Vaccination Card
- Copy of MIIC records showing dates and type shot(s) for COIVD-19 (To request use: https://www.health.state.mn.us/people/immunize/miic/records.html)
- V-Safe Record
- Insurance statement showing shots paid for by insurance company
- Any mobile app that shows proof of vaccine shots received (Docket Common Pass, Clear Health Pass, etc.)
- Showing or printing of any records from pharmacies or medical records. (e.g. Walmart shows proof of Vaccination on your pharmacy record online)
- Signed Employer signed letter attesting to Proof of Vaccination.
- If you were in a vaccine trial and can prove you did receive the vaccine, that will work also.
- Other options that shows vaccination not listed here but approved between now and conference.

Proof of Negative COVID-19 test within 72 hours of start of event. (Noon on Wednesday October 5) can be original, photo or copy of:

- Results from any diagnostic test for COVID-19. Antibody tests are not allowed.
- App showing proof of negative test
- Signed employer letter attesting to proof of negative test that took place 72 hours or less from start of conference (Noon Wednesday October 6th)
- Other options that shows vaccination not listed here but approved between now and conference.

If you get ill at the conference:

- Notify by phone or text Jim Louis with Best Meetings Inc. at 651-274-0209.
- Do not come to the conference meeting rooms.
- Take appropriate medical steps depending on how you are feeling.

Post conference

- We advise that anyone attending the conference in any way get a COVID-19 test 3-5 days after they leave.
- If anyone tests positive for COVID-19 within 10 days of leaving the conference please notify Best Meetings Inc. at 800-958-8875 and help them contact trace to inform people who attended.
- All Attendees/Speakers/Exhibitors/Hotel and Staff will be notified of any positive tests Best Meetings Inc. is informed about that happen within the 10 days after the conference.
