This has only been confounded by much misinformation from various sources in the community. These processes become more manageable with a working knowledge of the statutory requirements and understanding of the provider's options.

1. MDS Update - Colleen Toebe, Pathway Health - 1.25 CEU

This informational session will be on balancing the changes and challenges affecting long term care. The year 2023 will be remembered by the monumental regulatory changes directly affecting the long-term care organizations. Transformational changes include: the end of the public health emergency, the implementation of an updated resident assessment instrument focusing on social determinants of health (SDOH), enhancements to the Five Star Quality Program, and new measure added to both the quality reporting program and value-based purchasing.

1. SNF ICAR – Enhanced Barrier Precautions (MDH) - Tammy Hale - 1.25 CEU

This session will explore infection prevention and control efforts to reduce the spread of multidrug-resist organisms (MDROs). An important intervention to decrease resident risk of becoming colonized or developing an infection includes Enhanced Barrier Precautions (EBP). Measures to ensure proper implementation of EBP include staff education, resources, supplies and auditing of adherence and will be outlined.

2. AL Termination and Discharges - Rob Rode & Kari Everson - 1.25 CEU

Apparently you can't spell healthcare without "THC" or "ETOH". Effectively dealing with resident alcohol use and abuse remains a frequent issue we all face. With the governor's signature, cannabis use, possession, and home cultivation by Minnesotans 21 and older became legal on August 1. Legalization of recreational cannabis and cannabis products creates clinical, operational, and legal questions for healthcare organizations. Our settings are faced with navigating complex situations often with differing medical, personal, and ethical opinions. Knowing how we can respond to questions and concerns and navigate potential safety and compliance issues will help us work with residents, families, and staff in supporting successful individualized resident care.
